**MUNICIPAL ORDINANCE NO. 05, S. 2023**

**AN ORDINANCE APPROVING THE DISASTER RISK REDUCTION AND MANAGEMENT IN HEALTH (DRRM-H) PLAN OF THE MUNICIPALITY OF TERESA, RIZAL, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS**

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that "The State shall protect and promote the right to health of the people and instill health consciousness among them.";

WHEREAS, R.A No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, states that it is the policy of the State to mainstream disaster risk reduction and climate change in development processes such as policy formulation, socioeconomic development planning, budgeting and governance;

WHEREAS, Administrative Order No. 2020-0036 issued by the Department of Health (DOH) provides the guidelines on the institutionalization of Disaster Risk

Reduction and Management in Health (DRRM-H) Plan in Municipality-Wide Health Systems to develop an effective and efficient preparedness and response to public health emergencies and disasters; thus, ensuring delivery of essential population-based health services;

WHEREAS, after thorough examination of available documents relevant to the subject proposed legislative measure, the Sangguniang Bayan of Teresa deems it necessary to enact this Ordinance.

NOW THEREFORE, be it ORDAINED by the Sangguniang Bayan of Teresa, Rizal in session duly assembled, as it is hereby ORDAINED to enact:

**Section 1.** The Disaster Risk Reduction and Management in Health (DRRM-H) Plan of the Municipality of Teresa, Rizal, is hereby approved, subject to existing laws, rules and regulations.

**Section 2.** The provisions of this Ordinance are hereby deemed separable. If any provision hereof should be declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.


**Section 3.** All ordinances, resolutions and executive orders which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly. Let copies of this Ordinance be furnished the Office of the Municipal Mayor, Office of the Municipal Administrator, Municipal Disaster Risk Reduction and Management Office (MDRRMO), Teresa Rural Health Unit (RHU), Municipal Information Office (MIO), Department of the Interior and Local Government – Teresa (DILG-Teresa) and other concerned offices for their information, guidance and reference.

This Ordinance shall take effect immediately upon its approval.
