MUNICIPAL ORDINANCE NO. 11, S. 2023

AN ORDINANCE PROVIDING FOR A COMMUNITY-BASED MENTAL HEALTH PROGRAM AND DELIVERY SYSTEM IN THE MUNICIPALITY OF TERESA AND APPROPRIATING FUNDS THEREFOR

WHEREAS, the World Health Organization (WHO) defines mental health as "a state of well-being in which the individual realizes his or her own abilities, can cope with normal stresses of life, can work productively and fruitfully, and is able to make a contribution to his/her community";

WHEREAS, it also calls attention of the public that mental health is more than just the presence of a psychiatric disorder/sickness but more importantly, also redounds to a positive condition of one's mental well-being;

SECTION 19. APPROPRIATION. The amount necessary for the initial implementation of the provisions of this Ordinance shall be charged against the budget of the Municipal Health Office.

SECTION 20. REPEALING CLAUSE. All Ordinances, rules and regulations or parts thereof, found to be in conflict with, or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 21. EFFECTIVITY. This Ordinance shall take effect immediately posting in the three (3) consecutive places in the municipality.
