#### MUNICIPAL ORDINANCE NO. 14, S. 2023

AN ORDINANCE IMPLEMENTING PRE-EMPTIVE OR FORCED EVACUATION AS A CONSEQUENCE OF SUDDEN OCCURRENCES OF DISASTERS OR POTENTIALLY DEATH THREATENING SITUATIONS WITHIN THE MUNICIPALITY OF TERESA

WHEREAS, pursuant to Section 17 Basic Services and Facilities of Republic Act (R.A) 7160 of the Local Government Code of 1991 states that "...local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein.....such basic services and facilities include; social welfare services....";

WHEREAS, it is the primordial concern and responsibility of the Municipal government of Teresa, Rizal to institutionalize disaster management, in its program of governance, by way of instituting a system of creating awareness, training and

execution of the Order, he/she shall be presumed to have waived his/her rights for his/her protection.

SECTION 9. ORIENTATION AND TRAINING. To be effectively responsive in the efforts to implement Evacuation Program, the Municipal Disaster Risk Reduction and Management Office (MDRRMO) and Barangay Disaster Risk Reduction and Management Offices (BDRRMOs) shall jointly conduct a semi-annual Orientation and Training Program to ensure their readiness and expertise in dealing with any disaster incidents. All members of the Emergency Response Teams shall be equipped with the knowledge, technical know- how and other qualifying attributes which make them physically and emotionally ready in responding to disaster and calamitous events as they occur.

SECTION 10. JOINT CONFERENCE. At any time, the Municipal Mayor, at his own initiative, may request for a Joint Conference between and among the Sangguniang Bayan (SB), the Municipal Disaster Risk Reduction Management Office (MDRRMO) and the concerned Barangay Disaster Risk Reduction Management Offices (BDRRMOs) to fully explore discussions on the declaration and issuance of Pre-emptive or Forced Evacuation Orders in areas which are at risk from the detrimental effects of a given disaster. With this initiative, procedures and related processes are effectively abbreviated.

SECTION 11. SEPARABILITY CLAUSE. Should there be any provision .of this Ordinance, or any part thereof be declared invalid or unconstitutional, other provisions, insofar as they are separable from the invalid ones, shall remain to be in full force and effect.

SECTION 12. REPEALING CLAUSE. All laws and parts of laws, decrees, orders, resolutions, instructions, rules and regulations or parts thereof which are inconsistent with or in conflict herewith are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY CLAUSE. This Ordinance shall take effect after 15 days of posting in the three (3) consecutive places in the municipality.
