MUNICIPAL ORDINANCE NO. 22, S. 2023

AN ORDINANCE INSTITUTIONALIZING THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) IN THE MUNICIPALITY OF TERESA, RIZAL

WHEREAS, pursuant to Section 17 Basic Services and Facilities of Republic Act (R.A) 7160 of the Local Government Code of 1991 states that "...local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities";

WHEREAS, Section 16 or the General Welfare clause of the Local Government Code of 1991 provides that every government shall promote employment to uplift the lives of the constituents within the territorial jurisdictions;

SECTION 13. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon posting in three (3) conspicuous places in the municipality.
