## **MUNICIPAL ORDINANCE NO. 23, S. 2023**

AN ORDINANCE CREATING THE PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO) IN THE MUNICIPALITY OF TERESA, RIZAL AND FOR OTHER PURPOSES

WHEREAS, Section 16, General Welfare of the Local Government Code of 1991 provides that the social services shall be given a priority, thus efficient and effectives measures in the implementation are ensured;

WHEREAS, Samahan ng Mga May Kapansanan sa Teresa (SAMAKAT), a Civic Society Organization has been active with all programs, projects and activities of the Municipality;

5.2.3 Assist in the day-to-day operations and maintain updated database on disability and ensure its availability.

If the municipality is financially capable and has not exceeded the personnel services (PS) limitation, the Local Sanggunian may elevate the organization and staffing of the PDAO (Rule VI, IRR R.A. 10070).

Section VI. FUNDING. A regular annual budget shall be allocated from a portion in the five percent (5%) of Gender and Development Budget and from Internal Revenue Allotment (Rule VIII, IRR R.A. 10070) to ensure the implementation of the plans and programs for the benefit of persons with disabilities.

Sections VII. SEPARABILITY CLAUSE. If for whatever reason, any provision of the Ordinance is declared to be unconstitutional or invalid, the other provisions hereof not so affected shall continue in full force and effect.

Section VIII. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon posting in three (3) conspicuous places in the municipality.
