MUNICIPAL ORDINANCE NO. 26, S. 2023

REGISTRATION MANDATORY TO IMPLEMENTING ORDINANCE AN REGULATE, MONITOR, AND CONTROL THE MIGRATION OF TRANSIENTS OR MIGRANTS INTO THE TERRITORIAL JURISDICTION OF TERESA, RIZAL

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of the Philippines states that, the Local Chief Executive together with their Sanggunian shall promote the general welfare within the territorial jurisdiction;

WHEREAS, pursuant to Section 17 Basic Services and Facilities of Republic Act (RA) 7160 of the Local Government Code of 1991 states that "....local government unit shall exercise powers and discharge such as other function and responsibilities as are necessary to efficient and effective provision of the basic services and facilities;

WHEREAS, the Municipal Council of Teresa, Rizal adopts the policy to require all Barangay units to monitor the influx of transients and/or migrants into the geographical
