MUNICIPAL ORDINANCE NO. 37, S. 2023

AN ORDINANCE SEPARATING QUITERIO SAN JOSE ELEMENTARY SCHOOL SITIO IBABAW ANNEX IN BARANGAY DULUMBAYAN FROM QUITERIO SAN JOSE ELEMENTARY SCHOOL IN BARANGAY MAY-IBA, THIS MUNICIPALITY AND CONVERTING IT INTO AN INDEPENDENT SCHOOL TO BE KNOWN AS IBABAW 1 ELEMENTARY SCHOOL

WHEREAS, Article II , Section 17 of the 1987 Philippine Constitution provides *"the state shall give priority to education, Science and Technology, arts and culture and sports to foster patriotism and nationalism, accelerate social progress to promote total human liberation and development"*;

WHEREAS, education is one of the priority programs of the Municipal Government of Teresa, Rizal;

WHEREAS, in compliance to Section 7 (B) (13) of Republic Act No. 9155 otherwise known as "Governance of Basic Education Act of 2001" the approval of the
