

MUNICIPAL ORDINANCE NO. 03, S. 2024

AN ORDINANCE CREATING A TASK FORCE TO REGULATE AND MONITOR THE INSTALLATION OF POLES AND DISTRIBUTION LINES AND ENSURE ITS PROPER AND SAFE MAINTENANCE OF EVERY POWER OR ELECTRICITY GENERATING COMPANY, TELEPHONE, COMMUNICATION AND COMMUNITY CABLE ANTENNA TELEVISION UTILITIES WITHIN THE MUNICIPALITY OF TERESA, RIZAL

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "Every local government unit shall exercise the powers, expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effected governance, and those of which are essential to the promotion of the general welfare.
